

#### INTENT:

THE PURPOSE OF THIS BID IS TO SECURE A CONTRACT ON THE PURCHASE OF FORD MOTOR COMPANY TRUCK AND AUTOMOTIVE PARTS FOR ALL TULSA COUNTY DEPARTMENTS AND RELATED AGENCIES FOR A PERIOD OF ONE (1) YEAR BEGINNING MARCH 24, 2016 TO MARCH 23, 2017.

#### **GENERAL:**

THE BIDDER SHALL BID A PERCENTAGE DISCOUNT FROM THE CURRENT OEM PUBLISHED DEALERS PRICE LIST. PRICES ARE TO BE QUOTED NET, DELIVERED F.O.B. TO THE REQUESTING DEPARTMENTS.

ONLY BIDS FROM FRANCHISED PARTS DEALERS WILL BE ACCEPTED.

THE SUCCESSFUL BIDDER WILL BE REQUIRED TO FURNISH TO THE CENTRAL PURCHASING DEPARTMENT FIVE (5) COPIES OF THE CURRENT OEM PUBLISHED DEALERS PRICE LIST AND FIVE (5) COPIES OF EACH SUBSEQUENT PRICE LIST THEREAFTER, FOR THE DURATION OF THE CONTRACT.

IN THE EVENT OF MANUFACTURER'S PRICE CHANGES DURING THE CONTRACT PERIOD, THE PERCENTAGE DISCOUNTS WILL REMAIN THE SAME. IT WILL BE THE RESPONSIBILITY OF THE CONTRACT HOLDER TO NOTIFY TULSA COUNTY OF ANY PRICE INCREASES. NOTICE MUST BE IN WRITTEN FORM SUBSTANTIATED BY MANUFACTURER'S NOTIFICATION. SHOULD TULSA COUNTY ISSUE PURCHASE ORDERS FOR PARTS BASED ON OUT-DATED PRICE LISTS DUE TO FAILURE OF THE VENDOR TO COMPLY WITH THE FOREMENTIONED, THE OLD PRICES SHALL PREVAIL.

TULSA COUNTY DEPARTMENTS WILL INITIATE PURCHASE ORDERS ON AN AS NEEDED BASIS DURING THE CONTRACT PERIOD AS OUR REQUIREMENTS MANDATE.

BIDDER MUST HAVE DAILY DELIVERY SERVICE TO TULSA COUNTY'S VARIOUS DEPARTMENTS. BIDDERS FROM OUTSIDE THE COUNTY LIMITS OF TULSA MUST BE ABLE TO DELIVER WITHIN 24 HOURS AFTER RECEIPT OF ORDER ON ALL STOCK PARTS. IN THE EVENT OF UNREASONABLE DELAY IN DELIVERY, TULSA COUNTY WILL HAVE THE OPTION TO CANCEL THE ORDER AND/OR TO PURCHASE THE PARTS ON THE OPEN MARKET.
