AMENDMENT #2 - RESTAURANT, KITCHEN AND CONCESSIONARY SUPPLIES BID

ON MARCH 31, 2014, THE BOARD OF COUNTY COMMISSIONERS AWARDED A PARTIAL BID AWARD FOR RESTAURANT, KITCHEN, AND CONCESSIONARY SUPPLIES, FOR ALL USING TULSA COUNTY DEPARTMENTS, TO INDUSTRIAL MAINTENANCE SUPPLY, CMF #230631.

THE TULSA COUNTY PURCHASING DEPARTMENT WAS INFORMED FROM INDUSTRIAL MAINTENANCE SUPPLY THAT THEY CAN NO LONGER HONOR THEIR BID PRICING REGARDING HEAVY WEIGHT FOIL, 18" X 1000' (CC#7900 008 0004). INDUSTRIAL MAINTENANCE SUPPLY HAS NOTIFIED TULSA COUNTY THAT SIGNIFICANT PRICE INCREASES HAVE OCCURRED AND THEIR MANUFACTURERS HAVE ANNOUNCED INTENT TO IMPLEMENT INCREASES. THIS AMENDMENT IS DUE TO RISING COSTS IN RESIN AND RAW MATERIALS. THIS AMENDMENT IS TO CHANGE THE PRICE FROM \$39.26 PER ROLL TO \$45.50 PER ROLL. INDUSTRIAL MAINTENANCE SUPPLY STILL HAS THE LOWEST PRICE FOR THIS ITEM.
