FURTHERMORE, TO RESCIND THE BID AWARD FOR POLO SHIRTS, DEPUTY AND CIVILIAN STYLE, FROM GALLS, LLC TO OKLAHOMA POLICE SUPPLY AS WELL.

IN ADDITION, WE RESPECTFULLY REQUEST TO RESCIND THE BID AWARD FOR MEN'S AND WOMEN'S <u>POLYESTER</u> TROUSERS (ALL SIZES) FROM GALLS, LLC AND AWARD THEM INSTEAD TO CHIEF SUPPLY CORPORATION.

THE SHERIFF'S OFFICE AND THE PURCHASING DEPARTMENT REVIEWED THE BIDS AFTER IT WAS AWARDED AND IT WAS FOUND THAT GALLS LLC HAS A HIGH MINIMUM REQUIREMENT FOR THE ABOVE ITEMS THAT THE TULSA COUNTY SHERIFF'S OFFICE CANNOT MEET. IN ORDER TO RECEIVE GALLS' BID PRICING, IT WAS REQUIRED THAT THE SHERIFF'S OFFICE PURCHASE THAT MINIMUM REQUIREMENT.

OKLAHOMA POLICE SUPPLY AND CHIEF SUPPLY CORPORATION HAVE AGREED TO HONOR THEIR ORIGINAL BID PRICING ON THE ABOVE MENTIONED ITEMS AND STILL IS THE BEST BID PRICING FOR THESE ITEMS.
