and heirs, executors, administrators, assigns and successors, jointly and severally by these presents.

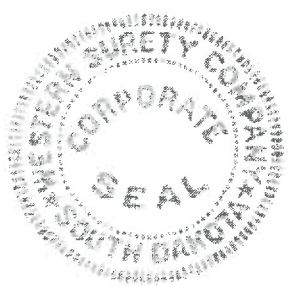

THEREFORE, if the principal obligor complies with all the statutes of the State of Oklahoma, and the rules and regulations and resolutions of Tulsa County or the BOARD OF COUNTY COMMISSIONERS OF TULSA COUNTY, OKLAHOMA, regarding moving buildings and houses along the highways and roads of Tulsa County and completes said moves without damage to the public roads, bridges and all other public property, then no claim shall be made against the bond and the surety shall not be liable to the BOARD OF COUNTY COMMISSIONERS. Should, however, damage occur to the public highways, roads or any other public property due to the actions of the principal or any of his agents, assigns, employees or those acting for or on his behalf, then the surety shall be responsible to the BOARD OF COUNTY COMMISSIONERS OF TULSA COUNTY for all damages occurring up to the amount of this bond, for the time period of February 16th, 2017 to February 16th, 2018.



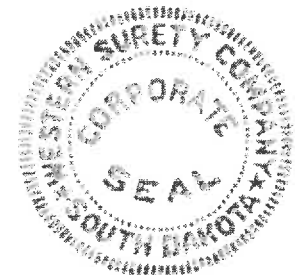

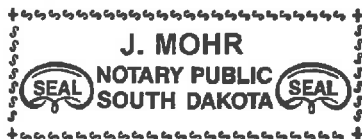
