Solicitation Condition and Specification Clarifications:

The specifications listed in Section 4.2 of the Request for Proposals are not requirements of the vendor's proposed solution but are highly desired features of video visitation services and system. Proposals on items of like quality will be considered if the proposal if noted and fully descriptive brochures enclosed.

Responses to Vendor-submitted Questions:

1. Can companies from Outside USA can apply for this? (like from India or Canada)

Response: Yes.

2. Do we need to come over there for meetings?

Response: Interested vendors must be present at the Mandatory Pre-proposal Conference and Site Tour which will be held on Monday, May 6, 2019 at 2:00pm CST at the David L. Moss Criminal Justice Center. Vendors not represented at this mandatory meeting will be ineligible for this solicitation. In addition, on-site visits required for installation and on-going maintenance will be expected.

3. Can we perform the tasks (related to RFP) outside USA? (like from India or Canada)

Response: Services may be performed outside the US, however on-site visits required for installation and on-going maintenance will be expected.

4. Can we submit the proposals via email?

Response: No, proposals cannot be submitted via email. As stated in the RFP, sealed proposals must be submitted to the Tulsa County Clerk's Office located at 500 South Denver Avenue, Room 117, Tulsa, Oklahoma 74103.
