ON JUNE 5, 2017, THE BOARD OF COUNTY COMMISSIONERS RECEIVED AND OPENED BIDS FOR THE SWAT TEAM TACTICAL ARMOR, IN WHICH TWO BIDS WERE SUBMITTED. ONE BIDDER WAS DISQUALIFIED DUE TO THEIR AFFIDAVIT WAS NOT AN ORIGINAL AS PER STATE STATUTE. THE OTHER BID RECEIVED EXCEEDED THE AVAILABLE BUDGETED FUNDS FOR THIS SERVICE. IT IS THE RECOMMENDATION OF THE TULSA COUNTY PURCHASING DEPARTMENT AND THE TULSA COUNTY SHERIFF'S OFFICE TO REJECT ALL BIDS RECEIVED AND RE-ADVERTISE WITH REVISED SPECIFICATIONS.
